**GENERAL MEMORANDUM NO. 063 – 24**

Subject: Appointment of American Samoa Development Disabilities Planning Council

Pursuant to A.S.C.A § 4.1304, I hereby reconstitute and make the following appointments to the American Samoa Developmental Disabilities Planning Council (DDPC).

American Samoa's DDPC is one of 56 Councils who are charged with identifying the most pressing needs of people with developmental disabilities in their state or territory. Councils are committed to advancing public policy and systems change that help these individuals gain more control over their lives.

DDPC members work to address identified needs by conducting advocacy, systems change, and capacity-building efforts that promote self-determination, integration, and inclusion. Key activities include conducting outreach, providing training and technical assistance, removing barriers, developing coalitions, encouraging citizen participation, and keeping policymakers informed about disability issues.

The composition of the Council must be diverse and at least 60% of them are individuals with developmental disabilities or their family members, working alongside Advocates and state agency representatives. This diversity enables Councils to better analyze and improve systems and services within a state and ensure that the voices of people with developmental disabilities and their families are heard. The term for Council members is three years.
